PARKING PERMIT APPLICATION

As a service to our community, we are able to offer a limited number of parking permits at no cost to our neighbours. Due to weight restrictions and other concerns, we limit parking permits to household passenger vehicles only. We will need details on your vehicle and your contact information as there may be times when you will need to remove your vehicle from our lot for various reasons. Please ensure that you read and agree to the following policies, waiver and disclaimer.

1. North Burlington Baptist Church Inc. and its leaders, directors, officers, employees, contractors, agents, volunteers, members and representatives (collectively referred to as “NBBC”), are not responsible for any injury, loss or damage of any kind whatsoever sustained by any person or their property (including, but not limited to, the parked vehicle and its contents) while on the property of NBBC. In consideration of NBBC allowing the vehicle owner/user (herein referred to as “vehicle owner”) to park on our property, the vehicle owner, on behalf of all passengers, agrees to:
 - Assume and accept all risks arising out of, associated with or related to use of the NBBC property
 - Waive and release NBBC from any and all liability for any loss, damage, injury (including loss of life) or expense that the vehicle owner or any passengers may suffer, or that their next of kin may suffer as a result of the use of NBBC property or the removal of the vehicle from NBBC property due to any cause whatsoever
 - Indemnify and hold harmless NBBC from any and all liability for damage to the personal property of, or personal injury to (including loss of life), any third party resulting from use of NBBC property
 - Indemnify and hold harmless NBBC from any and all claims, demands, actions and costs for any loss, injury (including loss of life), damage or expense whatsoever that might arise out of use of NBBC property
2. NBBC is not responsible for loss or theft of vehicles parked on NBBC property or for loss or theft to contents of those vehicles.
3. Please observe and obey all parking signs and parking lot markings.
4. In order to respect the privacy and rights of our neighbours, any loud music or inappropriate behaviour is prohibited.
5. Please ensure you leave our property in the condition you found it. Please report any breakage, damage, vehicle fluid leakage, etc. to the office promptly. NBBC reserves the right to assess costs for damage to NBBC property and bill the vehicle owner.
6. NBBC reserves the right to request that you remove your vehicle at any time, either permanently or on a temporary basis. We will attempt to give you notice whenever we can,

although this may not always be possible. We will normally attempt to contact you by phone, e-mail or by leaving a notice on your vehicle. If your vehicle remains on our lot at a time when it needs to be removed, it may be towed at your expense. To avoid this, please ensure that we always have your current contact information.

7. Only the vehicle(s) listed below may be parked using the assigned permit. The permit is not transferrable. Auxiliary vehicles, such as trailers, are not permitted without prior authorization.
8. NBBC reserves the right to place weight restrictions on vehicles parked on our property. Vehicles that appear to be over that limit may be towed at the vehicle owner's expense without notification. NBBC reserves the right to assess costs for any damage to NBBC property caused by overweight vehicles and bill the vehicle owner.
9. Vehicle owners are not permitted to remove the licence plates from their vehicle without prior consent from NBBC. Any vehicle found without plates may be towed at the owner's expense without notification.
10. Vehicles are to be parked in designated locations only. Any vehicle found outside of the designated area may be towed at the owner's expense without notification.
11. NBBC retains the right to allow vehicles normally excluded on a temporary basis at the discretion of the NBBC Board.
12. Cars are to be moved on Sunday mornings, for gathering.
13. Cars are to be moved for our Fall Fair on the first Saturday following Labour Day weekend.
14. All parking permits must be renewed in September and then on an annual basis.
15. Vehicle owners are not permitted to remove the licence plates from their vehicle without prior consent from NBBC. Any vehicle found without plates may be towed at the owner's expense without notification.
16. Vehicles are to be parked in designated locations only. Any vehicle found outside of the designated area may be towed at the owner's expense without notification.
17. NBBC retains the right to allow vehicles normally excluded on a temporary basis at the discretion of the NBBC Board.
18. Cars are to be moved on Sunday mornings, for gathering from 9:00a.m. to 1:00p.m..
19. Cars are to be moved for NBBC's Fall Fair on the first Saturday of September following Labour Day weekend, from 6:00a.m. to 6:00p.m.
20. All parking permits must be renewed in September and then on an annual basis.
